In August 2006, thousands of tonnes of hazardous waste from overseas were dumped at various sites around Abidjan, Côte d'Ivoire, leading to a humanitarian crisis. Sites including a lagoon, the sewage system and areas close to water sources were affected. Several people died as a result of the contamination and thousands reported health problems ranging from nose bleeds to respiratory problems and vomiting after inhaling fumes.

The Government of Côte d'Ivoire has been struggling to cope with the multi-million dollar costs of collecting and dispatching the toxic wastes abroad for decontamination. The Joint UNEP-OCHA Environment Unit deployed environmental experts to join the UN Disaster and Assessment Coordination (UNDAC) team that was sent to help national authorities assess and deal with the situation. UNEP and the Basel Convention, to which Côte d'Ivoire is a party, are supporting follow-up activities. UNEP has established a trust fund to assist with the clean-up.
